### MODEL DESCRIPTIONS

EBERLESTOCK FAC TRACK F3F.

The F3F has a big barn-door front opening, a zip-around top opening which optimizes it for PRC-117 type radios, MOLLE/PALS compatible webbing up the sides, and two exterior front pockets. This is a great all-around 3-day pack, but we named it the FAC Track because it is the best-in-class pack for Forward Air Controllers.

Features include:

- " Upper back wall radio rack with 3 antenna portals.
- " Padlock webbing tie-points all over the pack.
- " "Shooters harness" with 3D mesh is vertically adjustable for varying torso lengths, and is both thinner for shooting, and more comfortable for heavier loads.
- " Numerous small pockets and organizers - so you can always go right to what youre looking for.
- " Gossamer polycarbonate frame.
- " Handles on 3 sides make it easy to pick the pack up, especially when retrieving it from your vehicle.
