### MODEL DESCRIPTIONS

SOD NACC WAISTPACK.

The N.A.C.C. waistpack has been specifically custom designed for a department of Elite Italiano.

Made entirely of Cordura 1000 this belt pouch offers innumerable configuration options.

Special pocket for carrying the gun with emergency right-handed and left-handed opening. The pocket has a Velcro interface allowing to adjust height and to accommodate any gun available on the market.

The main compartment is protected by a concertinaed section that can be closed with a paracord to protect the interior from dust and water.

A front pocket is mounted on the main compartment and is closed with a YKK zip. Inside the pocket is a Velcro surface on which to mount other accessories such as magazine or torch holders.

The two waterproof side pockets are closed by a waterproof YKK zipper and can contain water-sensitive electronic material.

The retention thigh strap is removable.

The several PALS mounted on the entire structure allow to configure this belt pouch as a veritable platform allowing to supply weapon systems.
