## SPECTRE ASSAULT MEDIC BACKPACK

### MODEL DESCRIPTIONS

Tactical Medical Backpack with a capacity of approx. 23L.

Made entirely of Cordura 1000 this backpack has been requested by one of our elite corps.

It is composed of 2 main compartments.

The first compartment has a side totally covered in Velcro compatible with most of the removable medical pockets available on the market. The opposite side has two net pockets with a YKK zipper closure.

In the second compartment the first side is completely covered with elastic MOLLE with various sections for inserting different objects of varied sizes. The opposite side features two see-through pockets with a YKK zipper closure.

Externally there is a flat pocket with a YKK zipper closure.

The backpack is provided with compression straps at the bottom and with a special elasticated section compatible with our Tactical Litter.

The shoulder straps can be placed inside the special casing and a set of straps allows to mount the pack directly onto the body armours or plate carriers provided with the MOLLE system.

The pack is provided with a strong handle to remove it rapidly from the inside of vehicles or for practical transportation.
