## SPECTRE SNIPER SYSTEM PARKA

### MODEL DESCRIPTIONS

The Spectre Sniper Parka is a piece of the Spectre Sniper System.

This parka is made in NyCo50%50% and many different Cordura weights. A high tenacity mesh is used where the operator needs more transpiration.

The hood made in high tenacity mesh is ergonomic and can follow the movement of the head with adjustable elastic retentions.

The front side has a special comfort padding very lightweight and removable for protection when crawling on the ground.

Padding removable on the elbows.

Each sleeve has 2 pockets with YKK zips and on the back there are 2 Cordura utility pouches. One pouch has a special radio interface that allows you to keep the radio safe and pass the wires internally.

On the back there is an internal mesh pouch useful to insert hydration bladders. The back made in mesh keeps the transpiration.

All the structure of the parka is covered with a special grid made in paracord to set camouflage stuff.
